DIRECTION No. 01/2009

Government of Maharashtra has approved the implementation of revised pay scale of University and College teachers with effect from 1st January, 2006 vide G.R. Higher & Technical Education Department No. NGC 2009/(243/09)-UNI-1, dated 12th August, 2009, with direction to initiate action to frame suitable Statute under the relevant provision of the Maharashtra Universities Act, (Act XXXV of 1994) and to take immediate appropriate steps which may be required to implement the scheme of revision of pay scale for University and College teachers.

WHEREAS the terms and conditions of service of the teachers including Principal of Colleges/Director of Physical Education/Librarian, Demonstrator, Tutors etc. are to be laid down by prescribing the suitable Statute as provided under section 51(8) of the Maharashtra Universities Act. 1994;

AND WHEREAS the Senate, the Management Council and the Academic Council of the North Maharashtra University, have yet to consider the Draft Statutes and Ordinances with regard to the provisions made in the said resolution and which will take quite some time before these Authorities approve the Draft Statute/Ordinances and Hon'ble Chancellor's assent to it is to be received as per the provisions of the Maharashtra Universities Act, 1994;

AND WHEREAS the scheme of revision of pay scale 2006 is to be implemented within a period of one month from the date of the issue of the said G.R.;

Therefore, I, Prin. Dr. K. B. Patil, Vice-Chancellor of the North Maharashtra University, Jalgaon in exercise of the powers conferred upon me under section 14(8) of the Maharashtra Universities Act, 1994 in order to regulate the matter, hereby issue the following direction:

1. This direction may be called as "Revision of pay scales of teachers and equivalent cadres in Higher Education as per UGC Scheme (6th Pay Commission) Universities, Affiliated Colleges, Govt. Colleges/Institutes of Science etc." and are applicable to all categories of full time teachers employed by the North Maharashtra University and by affiliated Non-Government colleges and Recognized Institutes in the Faculties of Arts and Fine Arts, Mental Moral and Social Sciences. Science, Commerce, Law, Education (including Physical Education).

2. The Scheme of Revision of pay scale laid down in the said Resolution shall be made applicable as per Para No. 1 to 12. of the said Resolution along with its enclosures; Mutatis Mutandis.
